By opting into the Teams Transport mobile messaging program, you agree to these Terms & Conditions.

1. Program Description

Teams Transport provides automated and manual mobile alerts to customers and partners. When you opt-in to our service, you can expect to receive the following types of messages:

Customer Care: Assistance with account inquiries, technical support, troubleshooting, and two-way correspondence regarding your services.

Delivery Notifications: Real-time updates regarding shipment status, estimated arrival times (ETA), delivery confirmations, and coordination messages from logistics personnel.

2. Message Frequency

Message frequency may vary depending on your interaction with our services, the number of active shipments, or the volume of support requests initiated.

3. Pricing & Costs

Teams Transport does not charge for this service; however, message and data rates may apply from your mobile carrier. Check with your wireless provider for details on your text messaging plan.

4. Opt-Out & Stop

Your consent to receive these messages is not a condition of purchase. To opt out at any time, text STOP to the number from which you received the message. After texting STOP, you will receive one final confirmation text. You will no longer receive SMS messages from us unless you opt back in.

1. Collection and Use of Information

We collect your mobile phone number only when you explicitly provide it to us (e.g., through a web form, during account setup, or via professional agreement). This information is used exclusively to provide the services you have requested, specifically:

Customer Care: To respond to your inquiries and provide technical support.

Delivery Notifications: To send automated updates regarding shipment status, ETAs, and delivery coordination.

2. Non-Disclosure to Third Parties

We do not sell, rent, or lease your phone number or any SMS-related data to third parties. No mobile information will be shared with third parties or affiliates for marketing or promotional purposes. ### 3.

Data Sharing Exceptions

Personal information (excluding text messaging originator opt-in data and consent) may be shared with service providers who perform technical tasks on our behalf (such as the SMS gateway used to transmit the message). These providers are contractually obligated to use your information only to provide the specific service and are prohibited from using it for their own marketing.

We implement industry-standard security measures to protect your mobile data from unauthorized access, alteration, or disclosure.
